Government Resolution No. GAD- मातंस 080/4/2014-O/O DIRECTORATE OF IT-DIT (MH) dated 1<sup>st</sup> July 2014

**Introduction**

As per clause no. 3 in the above Government Resolution, *'It is mandatory that all the consultants deployed through this GR have **minimum 6 months** of work experience on an active project with the company and must have cleared eGov Certification of DIT, Govt. of Maharashtra with Distinction grade.'* Distinction grade implies that the candidate has cleared the Objective Test (i.e. obtained more than or equal to 75%) and has obtained a score of greater than or equal to 120 (out of 160) in Subjective Test and 25 (out of 40) in Interview.

Out of the Distinction Holders, the consultants who show exceptional qualities, domain knowledge and expertise are designated as Mentors by DIT. They are highly trained and certified resources that play an important role in the success of eGovernance Projects. Mentors provide the following support as part of eGovernance Training & Certification Programme:

- Provide expert advice and guidance to candidates
- Contribute towards updating the Question Bank with more relevant information
- Evaluate the subjective test answers submitted by candidates
- Conduct interviews of candidates who pass subjective test

The Project Implementation Committee (PIC) of DIT on 30<sup>th</sup> Dec 2014 observed that losing such valuable resources even for a period of 6 months may not be in the best interest of the State. The PIC decided that Mentors of the eGovernance Training & Certification Programme may be exempted from the clause that mandates '**minimum 6 months** of work experience on an active project' so that such good resources are allowed to continue working in the eGovernance Projects of Maharashtra.

**Resolution**

The clause no. 3 in the Government Resolution No. GAD- मातंस 080/4/2014-O/O DIRECTORATE OF IT-DIT (MH) dated 1<sup>st</sup> July 2014 stands revised as

*'It is mandatory that all the consultants deployed through this GR have minimum 6 months of work experience on an active project with the company and must have cleared eGov. Certification of DIT, Govt. of Maharashtra with distinction. However, Mentors of eGov. Certification, Govt. of Maharashtra, are exempted from the condition of minimum 6 months of work experience on an active project with the company. The updated list of these Mentors is available with DIT and any department willing to avail consultancy services from the empanelled companies shall approach DIT to get the updated list of Mentors.'*
